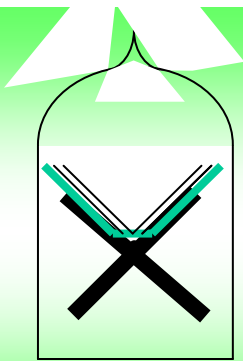

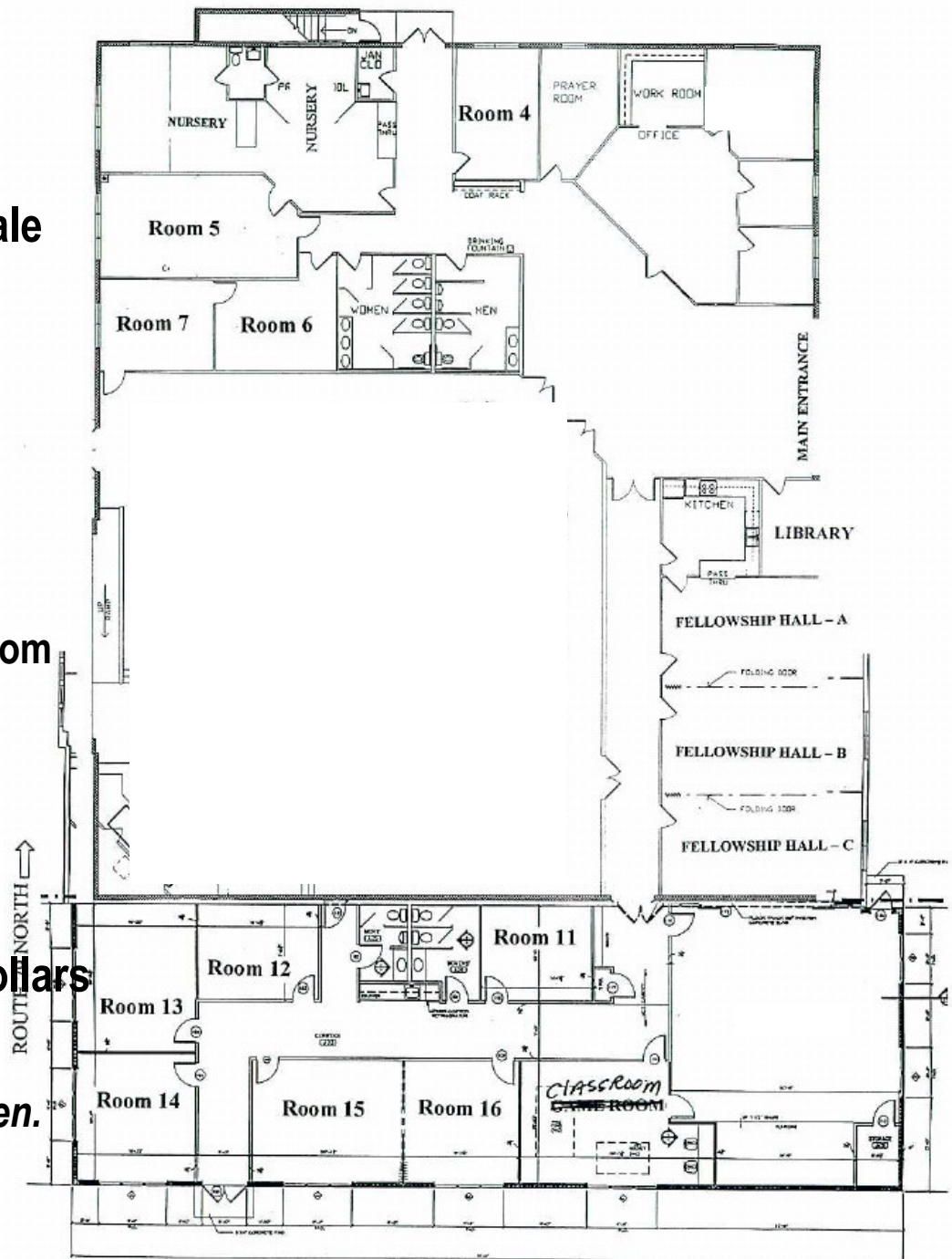
Future Plans Insha'Allaah

Why you should support ?

- Children are your future
 - Muslims migrated – forcing their children to grow in USA
 - Accountability to Allaah (SWT) for their Tarbiyah
 - Majority of children of Muslim Immigrants are going away from the Deen
 - Collective responsibility (even if your child is not in this school).
- Track record of our school Alhamdulillah:
 - Quality (Terra Nova Percentile scores in 90s, 5 years in a row)
 - Affordability (Least expensive school – effectively ~\$100 per month for 2nd/3rd 4th Child after deducting transport allowance)
 - Progress, Sacrificing Team, Efficient Resource Usage
- If you think Education is Expensive, Try Ignorance!



Issues with American Public Schools

- By age 13, half of the US teens say they can buy the drug marijuana and 43 % say they can buy drugs acid, cocaine or heroin
- Alcohol is the most frequently used substance among adolescents. In 1997 11 million children and adolescents were drinkers and more than 40% of them were binge drinkers
- In the next 24 hours in USA alone: 1439 teens will attempt suicide, 2795 teenage girls will become pregnant, 15006 teens will use drugs for the first time, and 3506 teens will run away
- In 1996, 4643 children and teenagers were killed with guns – 2866 murdered, 1309 by suicide, and 468 in accidental shootings. That means 13 deaths by a gun every day
- In 1998, 37.8% of grade 8 students, 49.3% of grade 10 students and 56.1% of grade 12 students tried at least one drug.
- One fourth of all adolescents contract a sexually transmitted disease before they graduate from high school
- *Because of such issues even in non-Muslims, over a million American children are leaving public schools for home schooling*

Dear Applicant:

Based on information supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3).

We have further determined that you are not a private foundation within the meaning of section 509(a) of the Code, because you are an organization described in sections 509(a)(1) and 170(b)(1)(A)(ii).

If your sources of support, or your purposes, character, or method of operation change, please let us know so we can consider the effect of the change on your exempt status and foundation status. In the case of an amendment to your organizational document or bylaws, please send us a copy of the amended document or bylaws. Also, you should inform us of all changes in your name or address.

As of January 1, 1984, you are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more you pay to each of your employees during a calendar year. You are not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Since you are not a private foundation, you are not subject to the excise taxes under Chapter 42 of the Code. However, if you are involved in an excess benefit transaction, that transaction might be subject to the excise taxes of section 4958. Additionally, you are not automatically exempt from other federal excise taxes. If you have any questions about excise, employment, or other federal taxes, please contact your key district office.
